with attending a committee meeting. Mr. Nuñez explains he has been on the board and has put his time into the board without reason and therefore has a full year of experience and has put in enough time for community hours. Followed by Marsha Peña and is the other opponent who is running for Senator of Culture Diversity and states this is her first time running, but asks for an opportunity. She has a bachelors from Cal State LA under sociology and feels she can be a great asset to the board with her knowledge and experience. Next, Kimberly Bond the association of the future fire fighters FFF club and spoke upon how ELAC has become a nonsmoking campus; however, is questioning the signs that are out around the campus due to the fact that they are extremely smaller than what she was expecting. President Lopez responded to Ms. Bond indicating that that issue can be fixed with the work and environment committee. Lastly, Antoinette Phillips treasurer of Los Angeles Trade Tech College came to invite the board to a car show event held on November the 20th from 10:00AM to 4:00PM. She brought up how our student unions should come together and get to know each other outside of office hours.

V. Financial Report

A. Vice President of Finance

- a. VP of Finance Dolarte provided the board with a BAC breakdown with an initial budget report ending in \$210,000 and a current budget report ending in 180,655.21. Commissioner Venegas question the current budget amount. VP of Finance clarifies that this amount is what is left over not including meeting's agenda proposals. Also attached a copy of the BAC Agenda Items breakdown. She also spoke upon her committee report and what was brought to her attention where the change in amount in size of how many students are in a classroom. A classroom that is less compacted brings results of higher grades.

B. Treasurer

- a. Treasurer Guo reports on how many committee meeting the board has attended with the total of \$125. Also brought up our DR List with the total amount ending in \$238.43.
