This growth was due to the fact that we hired a full-time Family and Consumer Studies faculty member in Fall 2019 and thus increased course offerings in this area. We also expanded our Family and Consumer Studies offerings at high schools in 2019-20.</b>

- **Certificates:** For this metric we reported (and set our ISS and stretch goal) based on the unduplicated number of students who received a State Chancellor's Office-approved certificate of any number of units.
- **Degrees:** For this metric we reported (and set our ISS and stretch goal) based on the unduplicated number of students who received a degree.
- **Transfer:** For this metric we reported (and set our ISS and stretch goal) based on the total number of students who transferred to California State University (CSU) and University of California (UC) System schools.
