

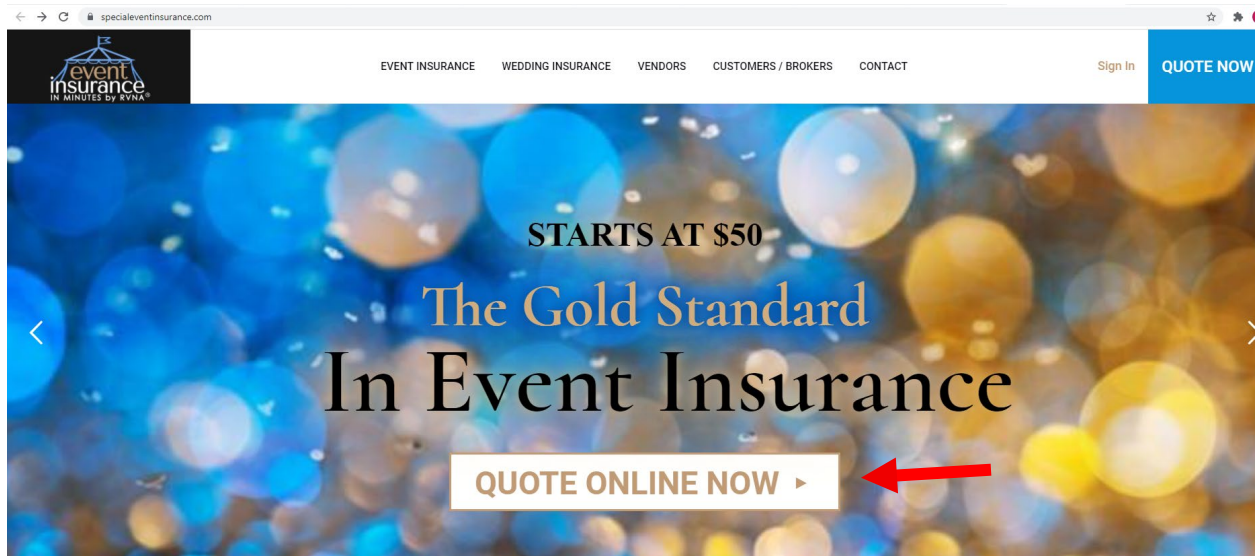
# RVNA – Quote Insurance for Single or Multiple Day Events

## Quick User Guide

### Step 2: Enter Event Information

1. Enter the Basics
  - a. Use the drop down to enter you are the Event Holder/Organizer/Host
  - b. Use the drop down to Select the State where the event will take place.
  - c. Use the drop down to select the type of event you will be hosting
  - d. Enter the Start Date
  - e. Number of Days Event will last. **Note-if the event is planned to go beyond midnight, add 1 day**
  - f. Enter Number of People Attending the event.

2. Select Your Coverage

- b. Use the Dropdown to select your coverage limits.

- Accident Medical Expense (No fault medical expense insurance for attendees)

- \$ 500,000/\$1,000,000 Per Occurrence/Annual Aggregate
